### **Dispute Resolution Service (DRS) – Mediators and Experts**

The Domain Name Commission operates a dispute resolution service (DRS) for .nz domain names. The service provides an alternative to the Courts in situations where two parties are in dispute over who the registrant of a .nz domain name should be. The DRS operates in a three-tiered manner, with the first tier being informal mediation, the second tier being expert adjudication and the third being an appeal process.

#### *Mediators*

The DRS uses a panel of nine mediators. Once appointed, a mediator is assigned to a dispute on a "first cab off the rank" basis as disputes are lodged with the service.

Mediators will then attempt to broker a solution to domain name disputes, using facilitation and negotiation skills to find common ground between complainants and respondents. The mediation period of the dispute process is of short duration and mediation will mainly be conducted by telephone.

If the dispute is not able to be resolved by mediation, an expert may be assigned to the case to adjudicate.

#### *Experts*

The DRS uses a panel of eight Experts to conduct determinations. Once appointed, an Expert is assigned to a dispute on a "first cab off the rank" basis as disputes are lodged with the service.

Experts adjudicate between complainants and respondents to determine the rightful holder of the name, giving consideration to the submissions made in the written complaint, response and reply, and additional written materials submitted as annexes. The Expert's decision is delivered as a written report, and is published on the DNC website. The decision is able to be appealed, in which case a panel of three Experts will consider the appeal case.

Applications for three Expert positions are currently being sought - please note that existing Experts whose terms are up will be invited to reapply. The following information for applicants is available:

The DNS project which will make improvements to the .nz DNS infrastructure is well underway. The key phases that will be occurring in the next 6 months include:

- The development of a plug and play Anycast DNS server has now been completed .
- NZRS is working with Waikato University's Wand Project on the selection of monitoring tools
- The selection of the hosting sites that will be used to replace the current Grace and Favour arrangements is well underway and expected to be completed during September.
