

## **.nz NEWSLETTER – DECEMBER 2003**

### **:: DNC Office ::**

Season's Greetings from the DNC office. We all hope you have the chance to take some time away from work over the year's end, and return refreshed for 2004.

### **Summary of the .nz market**

Since the last newsletter, no registrars have been authorised or connected. This means there are now 46 parties authorised as registrars, with 41 of those connected to production and offering .nz registration and management services – the same as in the November newsletter.

The level of active .nz domain names increased from 139,381 to 141,165, a net increase of 1,784. The .geek.nz second level domain shrank slightly in its third month in operation. Monthly registrations were at their lowest since May 2003.

### **NZOC Meeting**

The .nz Oversight Committee (NZOC) met on Monday 8 December. Formal minutes will be published shortly, but matters discussed included:

- NZRS (Nick Griffin and Carol Stigley – NZRS Chair) attended part of the meeting. Discussion included the outages in June and August, and related to the operation of plans associated with the move of the primary SRS site to Albany.
- NZOC agreed to adopt the draft Process on De-authorisation of a registrar policy (POD) as Version 2 of the policy. This was issued on 10 December. The policy is available at [http://dnc.org.nz/content/process\\_on\\_deauthorisation.pdf](http://dnc.org.nz/content/process_on_deauthorisation.pdf) for those interested.
- The ongoing review of the Zone File Transfer Policy was discussed, and NZOC established some policy principles to guide the drafting of a policy for consultation in the New Year.
- NZOC were briefed on the upcoming move to new premises in Willeston St.

### **2LD Policy Review**

The 2LD working group met in December and agreed the basic points for a draft 2LD policy. This will be developed early next year and a draft policy will be circulated for consultation. Thank you to all those who made submissions to the first stage of the Review.

### December Maintenance

The December maintenance window will be on December 28 07:00 – 10:00. This window is required to undertake the following work:

- a) Install an upgrade to registry only functionality.
- b) Update of OS and systems SW on the gateway.
- c) Reallocation of IP addresses for the Wellington site.
- d) Reboot all machines.

### Scheduled Outages and Updates

System availability for November was 99.91%, against the SLA standard of 99.9%. There were three unscheduled outages during November, all resulting from the move on 2 November to Albany as the primary SRS servers.

On December 7 there were a series of network outages on the TelstraClear network that meant that the SRS was unavailable.

Work has been progressing on the preparation of SRS to be published as Open Source on 30<sup>th</sup> January.
